DETAIL ON HOW TO MAKE A REQUEST FOR ACCESS - SECTION 51(e)

- The requester must complete Form C and submit this form together with a request fee, to the head of the private body
- The form must be submitted to the head of the private body at his/her address, fax number or email address
- The form must:
 - provide sufficient particulars to enable the head of the private body to identify the record/s requested and to identify the requester
 - o indicate which form of access is required
 - o specify a postal address or fax number of the request in the Republic
 - o identify the right that the requester is seeking to exercise or protect
 - o provide an explanation of why the requested record is required for the exercise or
